Introduction

LegaSea's vision is to restore our coastal fisheries to abundance. To do this we are striving to gain the confidence and support of organisations, brands and individuals throughout New Zealand.

A big part of this vision is to prevent further degradation of the marine environment. Before it is too late. Hauraki Gulf scallops being the latest example. It was clear that the population was at an all time low, yet we (the community) had to work remarkably hard to get the Minister of Oceans and Fisheries to close the remaining beds.

To add insult to injury, the parallel Hauraki Gulf Fisheries Plan run by Fisheries New Zealand (FNZ) proposes to ban recreational scallop dredging due to negative environmental impacts yet commercial scallop dredging will immediately recommence if the scallop fishery reopens. The hypocrisy is not lost on us.

Furthermore, we recently registered our concerns that the Fisheries Minister must stop all commercial dredging for kina in the Tory Channel, Marlborough Sounds.

The science is unequivocal, dredging is bad for the marine ecosystem and harms biodiversity. Yet it seems like FNZ is trying the same thing and expecting a different outcome. Isn't that the definition of insanity?

Public Awareness

Campaigns

HAURAKI GULF ALLIANCE

On 17 January 2023, Fisheries New Zealand released the final draft of the Hauraki Gulf Fisheries Plan for public consultation.

The Fisheries Plan is supposed to be aimed at restoring the health of the Hauraki Gulf Marine Park environment, yet Fisheries New Zealand are determined to allow destructive

fishing techniques such as bottom trawling, commercial scallop dredging and Danish seining to continue. It's clear the objectives in the final draft of the plan do not align with restoration of the Gulf marine environment.

As the public consultation of the Fisheries Plan was continually delayed, we reinvigorated our campaign with more billboards and emails to our databases in February 2023, to align with the consultation period.

This time, we included a submission form in our campaigning to encourage public feedback on bottom trawling, scallop dredging and Danish seining in the Marine Park. Over 7000 individual submissions were sent directly to Fisheries New Zealand using our online template, the vast majority supporting the call to ban these fishing techniques from Park waters.



As an Alliance we have over 100 organisations, charities and businesses involved, together we have generated over 31,000 individual signatures supporting the ban. We continue to run the petition while we await further decisions.

It has been a quiet summer for the LegaSea volunteer programme whilst we have been juggling the availability of our volunteers through cyclones, flooding and school holidays. Cyclone Gabrielle

Sadly the Hawke's Bay region has taken a major hit and the full consequences are yet to be quantified, but they are huge both in terms of financial loss and personal well-being. More than 500mls of rain fell overnight in most of the catchments of the Bay's five major river systems, taking outbridges and literally everything in its journey to the sea. Stopbanks failed to cope with the deluge, resulting in unbelievable flooding and widespread destruction of properties and loss of lives.

The effect on the marine environment has yet to be assessed, but the level of siltation is immense and the quantity of logs/slash beyond comprehension. To make things worse, the Napier Sewage Treatment plant at Awatoto was damaged and is still not functioning. Six weeks after the event raw sewage is still being pumped out into the Bay – just tragic.

Rāhui - Artificial Reef (LegaSea Reef)

Thanks everyone for your input into the submission supporting the application by mana whenua Hapu Trust for a 2 year closure to allow biogenic habitat to flourish without extended pressure. Such unity and support from LegaSea National, New Zealand Sport Fishing Council, New Zealand Angling & Casting Association and New Zealand Underwater is really appreciated.

We are excited to be working with mana whenua and Napier Port in this project over the next couple of years which will lead to a significant enhancement of the reef through seeding and will include extensive monitoring. This is such a great success story of collaboration, which we are proud of.

Te Whanga o Ruawharo rāhui

As a consequence of Cyclone Gabrielle a rāhui was placed on Te Whanga o Ruawharo (Hawke's Bay). LegaSea Hawkes Bay, through Wayne Bicknell, played an important and pivotal role in ensuring the recreational voice was heard and understood by mana whenua and MPI.

At times recreational considerations were overlooked and Wayne wearing a number of his hats was able, through a series of meetings and discussions with Mana Ahuriri Trust and MPI, to advance the recreational perspective not only pertaining to this rāhui, but also to restate the support shown by LHB for closures at Waimārama (pāua) and the Napier Artificial Reef and Bylaws for the Te Hoe Mataitai Reserve at Mahia.

Wayne's input on behalf of LHB has been well received and being invited to the rāhui uplifting ceremony at Westshore Beach was an honour. This bodes well for our continuing relationships with Mana Whenua.

Waimārama pāua

The rāhui for the gathering of pāua at Waimārama has been extended for a further 2 years to give the stock more time to rejuvenate and repopulate. We continue to work with Ngāti Kahungunu to ensure substantive monitoring is carried out during the closure.

The Kai Ika Project

LegaSea Hawkes Bay is working with the Hawke's Bay Sports Fishing Club on a trial Kai Ika project. Fifteen bins of fish heads and frames were collected from a fishing contest held on November 5th and 6th. These parts were distributed to those in need in the community. Subsequent adverse weather events have forced the cancellation of many Club fishing competitions, which has limited the supply of fish parts. When possible, some collections and distributions have continued. There are two upcoming fishing competitions that may provide further fish meals for Hawke's Bay families.

Twofold Bay

LegaSea Hawkes Bay has been given a redundant fishing trawler, the Twofold Bay, to scuttle in Hawke Bay waters for the purpose of creating an artificial reef and potentially a mecca for diving.

Two potential sites have been identified. The preferred option is in approx. 20 metres of water at Tongoia, north of the Port of Napier and the other site is at Ocean Beach, just to the South of Cape Kidnappers.

The vessel is tied up in the Napier Inner Harbour and is currently being assessed to determine what work needs to be done to prepare it for its final journey. Having done that, costings for the entire project can be put together and funding sought.

A number of organisations including NIWA have been approached for bathymetry and hydrographic information/resources to help guide the environmental considerations.

Key to obtaining Resource Consent, will be selling the project to mana whenua and the wider Hawke's Bay community. With support from the Mothership, Craig Thorburn from Kelly Tarltons and Norm Greenhall a funding application/prospectus is being compiled to assist in the process. Preliminary discussions have been held with the Napier Harbourmaster and Commercial Fishers and they have no objections to the preferred option at Tongoia.

Donations

The steadily increasing cost of living is resulting in a slow decline in recurring public donations. Because of the impacts of the current financial crisis on people, we have refrained from running any LegaSea Legend recruitment campaigns recently. As such, we expect lower than normal public donations this financial year. Consequently, distributions from LegaSea's public donations to the New Zealand Sport Fishing Council will also be down from previous levels. The good news is, the team is committed to maintaining the four workstreams supported by these donations: Advocacy, Research, Education and Alignment.

Fisheries Management update

Submissions update

Working alongside the New Zealand Sport Fishing Council, New Zealand Angling & Casting Association and the New Zealand Underwater Association, we have been busy making submissions on the following:

- Northland rock lobster (CRA 1) We submitted in support of a package including a 50% reduction to the commercial catch limit, effort controls on commercial potting, a reduced recreational daily bag limit and a split in the large management area.
- 2. <u>Coromandel scallops</u> (SCA CS) we submitted in support of a full closure of the Coromandel scallop fishery under section 11 of the Fisheries Act. The Minister agreed with our submission and closed the fishery from 1 April 2023.
- 3. <u>Tory Channel kina dredging</u> we submitted in support of a full ban on dredging in the Tory Channel. Scallop dredging is already prohibited.
- 4. <u>Te rāhui o Moremore</u> with LegaSea Hawkes Bay we submitted in support of marine protection around a new, artificial reef off Napier Port. The 2-year temporary closure application is supported by the community and led by the Mana Whenua Hapū Trust.
- 5. <u>Hauraki Gulf Fisheries Plan</u> Between January and March we worked on a submission opposing the draft Fisheries Plan, instead supporting more bold, time-bound actions to provide for meaningful change.

World Recreational Fishing Conference



Momoko Burgess (New Zealand Sport Fishing Council, LegaSea), Sydney Curtis (New Zealand Sport Fishing Council, Bluewater Marine Research, LegaSea) and John Holdsworth (New Zealand Sport Fishing Council, Bluewater Marine Research) attended the World Recreational Fishing Conference in Melbourne from the 19th to 22nd February 2023. The theme of the conference this year was 'Keeping Pace in a Dynamic and Challenging World with Changing Fisheries'. This is an ode to the fluid and rapidly changing landscape and acknowledges the challenges for researchers, managers and anglers involved in recreational fisheries.

There is a lot of diversity in who fishes and how they fish and manage fisheries, and it was good to see that diversity reflected in the 350 attendees at the conference.

There was particular interest in LegaSea from other NGOs. Despite countries or states having peak bodies and some government funding, a number of people working in the NGOs felt under-resourced and often ignored on issues important to them.

Our team benefited from the conference by learning from and enquiring further into particular areas of research and management. We are confident our learnings and connections made will be beneficial to the New Zealand Sport Fishing Council and LegaSea. The team are grateful for the opportunity to present and attend.

We would like to acknowledge and thank the New Zealand Marine Research Foundation for funding this conference opportunity, and we also thank the New Zealand Sport Fishing Council for their support.
